Advanced Metering Opt-Out

River Falls Municipal Utilities (RFMU) is making use of Advanced Metering technology, which allows safe, secure and effective two-way communication and proactive customer service while improving system reliability and operating efficiency. Through the AMI Project, RFMU has adopted advanced meters as standard equipment for customers. Residential customers who elect a non-standard meter shall pay a monthly meter reading charge for each non-standard meter. Eligibility Guidelines for Opt-Out

- You must be a residential customer.
- Non-property owners who wish to opt out must obtain signed permission from the property owner.
- You are responsible for providing and maintaining access to RFMU for purposes of meter installation, maintenance and reading. Failure to provide and maintain access to RFMU may result in termination of your opt-out participation along with installation of AMI.
- Net metering customers are not eligible to opt-out.

I understand that I will not be eligible to receive any other enhanced benefits that the Advanced Metering system may provide. I agree that I will maintain clear and direct access to my meter(s) allowing RFMU employees to access the meter(s) during typical business hours throughout the month.
