

Housing Fee Report

Effective January 1, 2019, Wisconsin Act 243 amended §66.10014, Wis. Stats. to require that all cities and villages with a population of 10,000 or more prepare a report on residential development fees and publish the report on the municipal website. This report was prepared by the Community Development Department for the calendar year ending December 31, 2018, using the permit/development records maintained by the Inspections Division and the 2018 City of River Falls fee schedule. For record-keeping purposes, projects are reported in the year in which they were permitted. Projects approved in prior calendar years but completed and occupied in 2018 are not included in this report. Table 1 lists the building permit fee schedule. Table 2 lists all other development fees imposed by the City of River Falls and the total collected for each in 2018.
